Transmission of personal data to third parties

Inspection, correction and deletion of personal data

The companies take appropriate measures to protect your personal information against loss, unauthorized access, unlawful processing and publication. So we make sure that only the necessary people have access to your data, that the access to the personal data is protected and that our security measures will be checked regularly.
